INDIVIDUAL GRANTING EXCEPTION TO SPACING**

Read & initial each bullet

- Only one proposed well for each exception to spacing form. _____
- Exception to Spacing form needs to be submitted with a permit application or registration form with a \$250 deposit for each application/form. [GGCD Rule 8] _____
- If no deposit is made, exception to spacing form will be considered administratively incomplete and will not be presented to the Board for consideration of approval. [GGCD Rules & By-Laws; Rule 4] _____
- Well locations, according to GPS, must be within 100 feet of the proposed well location. If drilled location exceeds 100 feet, deposit will be forfeited. [GGCD Rules & By-Laws; Rule 9] _____
- This exception to spacing form shall remain valid for four (4) months from the approval date. It shall thereafter become void unless a permit or registration extension has been requested and approved during the first four (4) month period. [GGCD Rules & By-Laws; Rule 11] _____
- This form shall not be construed to limit the power of the Board and the powers stated are cumulative only of all other powers possessed by the Board. [GGCD Rule 8] _____
- This form does not constitute an approval to drill a well. _____

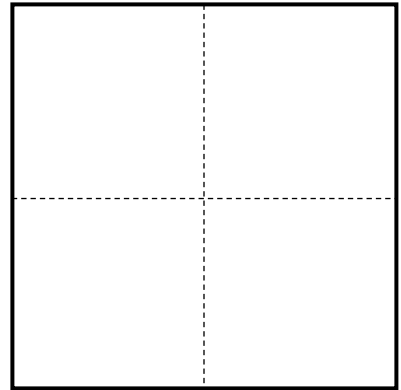
